## **Resource Sharing**

- Allows network members to optimize service delivery to their patrons
- Maximizes cooperation, emphasizes efficiencies and cost savings
- Encourages consolidation, integration and sharing between member institutions


## **Resource Sharing – General Requirements**

- Agreements to share materials and supply services
- Establishment of consistency and service levels
- Agreement on policies
- Creation of a group responsible for recommending shared policies and best practices
- Creation of a process for members to suggest changes to shared policies

## **Resource Sharing in Alma - Broker**

- Works with a dedicated system to provide discovery, requesting, or both
  - Broker manages the requesting process
  - Alma handles the circulation processes
- Requires no patron data sharing agreements
- Lending policies are handled by each institution


# **Resource Sharing in Alma - Broker**



## **Resource Sharing in Alma – Peer to Peer**

- Alma interacts directly with the lending/borrowing institutions to provide/get the resource
- Requires no patron data sharing agreements
- Lending policies can be handled by each library
- Title-level requesting allows for multiple partners to fulfill the request

## Resource Sharing in Alma – Fulfillment Network

- Enables Walk-in Borrowing
- Requires a patron data sharing agreement
- The member institutions' inventory is searchable by patrons of all network member institutions.
- Pick Up Anywhere functionality is anticipated for 2016.
- Full functionality in Fulfillment Networks is slated for 2017.

## **Resource Sharing in Alma – Fulfillment Network**

#### Policies to Consider – Shared Data

- Do you have a Data Sharing Agreement in place?
- What data can be searched by all institutions?
- Can patron information be shared freely among all members?
- Will some members share patron information with other institutions? (Allows walk-in borrowing)

#### **Policies to Consider – Shared Standards**

- What types of items will you circulate?
- What will you use for a Courier/delivery mechanism?
- Is there a guaranteed turnaround time on requests?

### Policies to Consider - Shared Fulfillment

- Will all Resource Sharing items have the same circulation periods?
- Are digitization/document delivery requests allowed?
- Are recalls allowed?
- Are renewals allowed?
- Will all libraries charge the same fines/fees for Resource Sharing items?

- Rota assignment rules
- Resource locate profiles
